

I LOVE MY PET

I love my pet and agree to the following rules and conditions when staying at the Friendly Fun Vallarta Hotel:

A maximum of two domestic pets per room is allowed.

I must show my pet's vaccination card or legal documents (permits, licenses) upon arrival at the hotel.

- Payment will be made at the time of check-in at the reception area, and a charge of 900 pesos per pet (maximum 2 pets per room) per day.
- I agree to leave as a guarantee at check-in the amount of \$1,000.00 pesos for damages that my pet may cause or for taking food from the buffet and giving it to my pet.
- I agree to keep my pet on a leash inside the permitted common areas, which are: outside the restaurant "El Palmar", in front of the beach and Friendly Fun esplanade; or inside a cage while in the public areas.
- Special cleaning of my room is extra cost.
- Daycare, esthetics and veterinary services are available at an extra charge and through an external provider outside the hotel.
- I agree that I will be assigned a room on a special floor, which may be: first floor of tower A and C, with the possibility of "upgrade" to floor 5 with extra charge.
- I agree to keep my pet away from all areas where food is served (restaurants), including the pool, tennis court, spa and gym areas.
- I agree to be present while any member of the hotel staff, housekeeping or maintenance is in the room. Room cleaning should be scheduled in advance and occur when the pet is not in the room or the owner is present.
- I agree that my pet will not be given access to my pet if it shows signs of unsolvable conditions or contagious disease, or if it demonstrates aggressive behavior toward others.
- I agree to keep my pet with me or leave it with a designated person at all times, and will not leave it alone in the room.
- I agree to avoid noise or any other disturbance that my pet may cause to the detriment of other guests in the hotel.
- I agree to pay additional cleaning or repair bills if necessary and authorize the hotel to charge my credit card for such charges, even if after my departure from the hotel.



- I agree that, if my pet creates a disturbance that causes complaints to the hotel by other guests or hotel staff, at the request of the hotel manager, I will be responsible for making immediate arrangements to find accommodations for my pet outside of the hotel.
- If for any reason you are caught taking food from the all-inclusive to give it to the pet, there will be an extra charge of \$1,000.00 pesos (which will be taken from the deposit I left as a guarantee for damages to the property).
